Sub: Re-engagement of Retired Railway employee against 02 post of Stenographer and 01 post of Account Assistant on daily basis.

1. Applications are invited from interested retired Railway employee who are retired on or before 31/10/2017 for the 02 post of Stenographer and 01 post of Account Assistance of Indian Railways, and are below 62 years as on 31/10/2019 for re-engagement.

2. Terms and Conditions:

- I. Maximum upper-age limit for re-engagement is 62 years up to 31/10/2019
- II. Re-engagement will be terminated after attaining the age of 62 years.
- III. Re-engagement shall be up-to the availability of regular candidates from RRB/RRC or 62 years which ever earlier.
- IV. Administration is at liberty to terminate services of the reengaged employees in case their works/conduct is found unsatisfactory.
- V. Employees retired under the Safety Related Retirement Scheme/Liberalized Active Retirement Scheme for Guaranteed Employment for Safety Staff/Removed/Dismissed/Compulsory retired employees as a result of disciplinary action or in review are not eligible for re-engagement.
- VI. Re-engaged employees are not entitled for any other benefits or facilities except the daily fixed remuneration as shown below as per Railway Board RBE No. 219/09:

Rs.320/- per day	Retired Stenographer/Account Assistant up to GP 2800/-, Level 5
Rs.550/- per day	Retired Stenographer/Account Assistant, GP 4200, Level 6
Rs. 565/- per day	Retired Stenographer/Account Assistant, GP 4600/- Level 7

- VII. Retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
 - VIII. Re-engagement shall be subject to their prescribed medical fitness for the category certified by the designated authorities.
 - IX. Suitability/competency of the applicant shall be adjudged before their re-engagement through screening/practical test.
 - X. The duty hours of the re-engaged employee would be the same as applicable to the post against which he is re-employed.
 - XI. Copy of any one of the following documents should be attached with the application: (i) Service Certificate/ (ii) Pensioner Identity Card/ (iii) Pension Payment Order.
 - XII. The last date for submission of the application is 15/11/2017 up to 17:00 hours at NP Office, Cybrary Building , National Academy of Indian Railways (Formerly Railway Staff College), Lalbaug, PO- Pratapnagar, Vadodara-390004.
3. Retired employee of Indian Railways desirous for re-engagement, on the terms and conditions as mentioned above, are to submit their application in the prescribed format at Annexure-A to this office.
